OPPOSED MOTIONS FOR THE WEEK OF 28 APRIL – 30 APRIL 2026

BEFORE THE HONOURABLE MADAM JUSTICE VUMA J

1. Matters will be conducted in open court at 10:00.
2. The parties are directed to liaise with one another and advise the Judge's Secretary, by no later than **Friday, the 24th of April 2025 at 10h00**, of their mutually agreed preferred date for the hearing.
3. The Court will endeavour, where practicable, to accommodate the date proposed by agreement between the parties. Where no agreement has been reached, roll call will be held on **Tuesday, the 28th of April 2025 at 09:30**.
4. Parties should ensure that the Heads of Argument and Joint Practice Notes are filed on CaseLines no later than **24th April 2026 at 10h00**. Practice Notes should set out, amongst other things, legal practitioner's contact details (names, email addresses and contact numbers), issues required for determination, relevant portions of the papers to be read, common cause facts relevant to the relief sought in the pleadings and the estimated duration of the hearing. A hard copy of the Heads of argument and draft order to be made available for the court before the matter commences. Parties should ensure compliance with the relevant directives pertaining to the delivery and uploading of both parties' Heads of argument and court orders obtained through an application to compel.
5. Kindly take further notice that the uploading of documents on CaseLines outside the stipulated times and without condonation will result in the matter being struck off the roll and costs *de bonis propriis* may be ordered against the errant practitioner.
6. Notices of removals, postponements and settlements should be uploaded on Caselines or emailed to LNyilika@judiciary.org.za by no later than **24th April 2026 at 10h00**.
7. Introductions will be done in Open Court.

8. Counsel must bring 2 (two) hardcopies of draft orders to court.
9. All draft orders to be in word and pdf format and to be uploaded on Caselines. Kindly ensure that it complies with the Judge President's Consolidated Practice Directive 1 of 2024 (, i.e. the Judge's name, date, mode of hearing etc.), Including the below disclaimer:

"This Order is made an Order of Court by the Judge whose name is reflected herein, duly stamped by the Registrar of the Court and is submitted electronically to the Parties/their legal representatives by email. This Order is further uploaded to the electronic file of this matter on Case Lines by the Judge or her Secretary. The date of this Order is deemed to be .. April 2026."

10. Draft orders must correctly reflect the number on the roll and the correct case number.
11. The court will not deal with matters that were not placed timeously. If your matter was properly enrolled but does not appear on this roll, please contact the enrolment office.
12. Please allow 7 (seven) court days for signed orders to be uploaded.
