dates of availability before matters are allocated. Parties will be restricted

to their time estimation as per Practice Note in order to enable adequate

allocations on the days available in view of the Public holiday (Friday)

Authorities if any and 1 Copy of the proposed Draft orders depicting the

details of the court room (i.e Court 4B) Judge presiding over the matter (Judge

Holland-Muter) and the details of the instructing attorneys and appearances on
