DIRECTIVE BY THE HONOURABLE JUSTICE VIVIAN AJ

- [1] Applications will be heard in open court. The court in which the matters will be heard will be reflected on the day roll which is circulated daily. Only in the event of unforeseen circumstances will matters be dealt with on electronic platforms and in such an event a video link for a virtual sitting will be circulated. Practitioners will be informed in writing as soon as reasonably possible if hearings are to be conducted virtually.
- [2] No matter will stand down for any purpose. Parties must be at Court on the allocated date and at the allocated time.
- [3] Parties are required to upload a joint practice note (if this has not yet been done) by **13h00 on Friday 8 August 2025.** Matters with no current practice note may be struck from the roll in the absence of good cause.
- [4] Draft orders are to be uploaded onto Caselines in PDF and WORD format and emailed to Ms Tshepang Mpuru at TsMpuru@judiciary.org.za in Word format by 13h00 on Friday 8 August 2025. Two copies are to be handed up when the matter is heard.
- [5] Removals, postponements and settlements must be brought to the attention of our office forthwith by a **Widely Shared Note on CaseLines** and emailed to Ms Mpuru
- [6] Matters 5, 6, 7 and 8 are to be heard concurrently. Counsel are requested to upload a joint schedule highlighting any material differences between the matters. Counsel should prepare to argue matter number 5 and thereafter to refer to the schedule insofar as this will affect the outcome of matters 6, 7 and 8.
