## OPPOSED MOTIONS DIRECTIVE: 18 – 22 AUGUST 2025 MATTERS BEFORE JUSTICE K MANAMELA AJ

## TO : ALL LEGAL PRACTITIONERS

- 1. Kindly note that the matters detailed in the attached opposed motion roll have been allocated to **Manamela AJ**.
- All matters will be heard in open Court, unless consensus is reached between counsel appearing and it is convenient to the Court. For those matters which will be dealt with in open Court the parties will be informed of the courtroom prior to the hearing.
- 3. All documents and the <u>joint practice note</u> in each matter if not yet done must be uploaded onto CaseLines by no later than Wednesday, 13 August 2025 and must also be emailed to Vntoni@judiciary.org.za.
- 4. Counsel should, subject to the deadline in 3 above, ensure that the joint practice note filed shall address all the requirements detailed in paragraph 25 of the Judge President's Consolidated Practice Directive of 2024. Should a joint practice note not be filed, the parties must each file a separate practice note and may indicate why a joint practice note could not be filed. The practice note must indicate under which sections the relevant papers which must be read, are to be found on CaseLines.
- 5. Parties are requested to file a chronology simultaneously with the practice note.
- 6. Parties are requested to email proposed draft orders in Word format to Vntoni@judiciary.org.za at least a day before a particular matter is enrolled and

must be uploaded on CaseLines. Parties are requested to bring a hard copy of the proposed draft order to Court.

- 7. Where matters are to be removed, postponed or have become settled, the parties must inform the Judge's Secretary as soon as possible.
- 8. Introductions are not necessary, and parties may introduce themselves on calling of their matters.
