2. Counsel and Litigants introductions will be conducted in court
3. Counsel are not expected to hold themselves available for any day other than the day for which their matter is allocated.
4. All matters must be accessible on CaseLine and the Judge's secretary must be invited to the CaseLine file as well. Further, matter must be properly bundled/activated on CaseLine on or before 12h00 noon on **Friday, 22 August 2025**. Failure to comply will lead to the matter being struck off from the Court's roll.

5. Draft orders must be uploaded onto CaseLine and 1 copy handed up in court. Counsel must ensure that the draft orders have the correct case number and the correct prayers prayed for are included, as no order will be amended after it has been granted in court.
6. Any removals, settlements and postponements should kindly be communicated to the Judges Secretary as soon as possible.
7. Counsel/ Practitioners should ensure compliance with the relevant Directives pertaining to unopposed motions.
