OPPOSED MOTIONS DIRECTIVE 1-5 SEPTEMBER 2025

BEFORE THE HONOURABLE JUSTICE ALLY AJ

TO : ALL LEGAL PRACTITIONERS

1. Kindly note that the matters detailed in the attached opposed motion roll have been allocated to Justice **Ally AJ**.
2. All matters will be heard in Open Court, unless determined otherwise by the Judge in consultation with the parties. **There is a possibility that matters allocated for 1 and 2 September 2025 might be heard virtually but parties will be notified timeously.**
3. There will be **no roll call** as all matters have been allocated, albeit some provisionally for non-compliance with the Practice Directive.
4. For those matters which will be dealt with in open Court the parties will be informed of the courtroom prior to the hearing.
5. All documents and the joint practice note in each matter – if not yet done - **must** be uploaded onto CaseLines by no later than Wednesday, 27 August 2025.

6. Counsel **must**, subject to the deadline in 4 above, ensure that the joint practice note filed will address all the requirements detailed in paragraph 25 of the Judge President's Consolidated Practice Directive of 2024.
7. Should a joint practice note not be filed, the parties **must** each file a separate practice note and may indicate why a joint practice note could not be filed.
8. The practice note **must** indicate under which sections the relevant papers which must be read, are to be found on CaseLines.
9. Parties are requested to file a chronology simultaneously with the practice note. Parties are requested to email proposed draft orders in Word format to AMashala-Shiburi@judiciary.org.za /0734768834 at least a day before a particular matter is enrolled and must be uploaded on CaseLines.
10. Where matters are to be removed, postponed or have become settled, the parties **must** inform the Judge's Secretary as soon as possible.
- 11. Introductions are not necessary, and parties may introduce themselves when their matters are called.**
