6. Practice Notes and Heads of Argument should already be uploaded onto caselines. If you have not done so, please do so by no later than 16:00 on Friday, 13 February 2026.
7. One copy of the Order/Draft Order, where applicable should be handed up in court. If the parties need a signed Court order only, two copies must be handed up in court.
8. The order made in court, stamped and signed by the registrar, will be uploaded onto caselines within a day after the order was made or as soon as possible as workload permitted.
9. No documents or orders should be e-mailed, everything must be uploaded onto caselines.
10. Please inform our office as soon as possible if a matter is settled or removed.
11. It is not necessary for legal practitioners to come and introduce themselves to the Judge in chambers as they may do so when their matter is called in court.
