DIRECTIVES FOR UNOPPOSED MOTIONS BEFORE HONOURABLE MAZIBUKO
J - 12 - 16 JANUARY 2026.

1. Kindly take note that there will only be open Court appearances, in light of the Judge President's Notice No.1 of 2025 dated 26 February 2025. Court will commence at 10h00. Kindly refer to the Day Roll for the issued Court.
2. In person litigants should come to the general office for assistance.
3. Introductions will take place at 09:45 a.m. in Chambers no 23, 2nd Floor (Palace of Justice).
4. Kindly take further note that the Court will start by calling for removals, settlements and postponements. Thereafter matters will be called page by page in order of Seniority. Should Counsel have more than one matter on the roll, having called the first matter, Counsel will be permitted to proceed to call any other matter wherein they appear.
5. Kindly ensure that your Practice Notes and Draft Orders directed for the attention of Mazibuko J are uploaded on Caselines in Word and PDF format.

Draft orders should contain a disclaimer, indicating the date of hearing, Judge's names (i.e Mazibuko J), manner of hearing (i.e Court) and the name and details of Counsel and those of the instructing attorneys.

Counsel/practitioners should ensure that all documents are filed on Caselines by no later than close of business on the 9th of January 2026 for matters being heard on the 12 of January 2026, by 12th of January 2026 for matters being heard on the 14th of January 2026 and by 14th January 2026 for matters being heard on the 16th January 2026.

8. Counsel/ Practitioners should ensure compliance with the relevant Directives pertaining to Unopposed Motions, and the decorum of the Court, is to be maintained at all times.
