## **OPPOSED MOTION DIRECTIVE:**

- 1. The **date** and **time** of the hearing of each of the matters are set out in the allocated roll below.
- 2. Matters will be heard in **open court** and the parties need to appear on the date and time reflected on the allocated roll below.
- 3. Parties must check the allocated court room on the day roll.
- 4. A Joint Practice Note has to be filed in all matters and must be uploaded onto Caselines by no later than **Friday**, **16 May 2025 at 12:00** (noon). The parties are requested to ensure that the Joint Practice Note deals with all aspects identified in paragraph 25.17 of the Judge President's Consolidated Practice Directive 1 of 2024.

- 5. To assist the Judge in the deliberation of the matters on his roll and to prevent matters from being struck from the roll, consideration of compliance with the relevant directives pertaining to opposed motions will apply.
- 6. Parties should ensure that proposed draft orders are uploaded in word format onto Caselines at least a day before a particular matter will be heard. Draft orders should indicate the hearing date of the matter, the Judge's name (Maritz AJ), and at the end of the draft order the names and details of all counsel/practitioners and their instructing attorneys must be included. Parties must bring ONE hard copy of Draft order sought.
