Should there not be a joint practice note filed by both parties, or, should there be no heads of argument, and practice note filed by one of the parties, Counsel appearing will be required to demonstrate that the notice of set down has indeed been served on the opposing side, in terms of the relevant rules and practice directives.
7. Indexed and paginated bundles pleadings and documents are to be accessible on caselines in accordance with the Consolidated Practice Directive 1 of 2024 as amended, failing which matters may be removed or struck from the roll. If your matter is inaccessible or unavailable on caselines, this will be indicated on the attached roll, and the parties will be required to rectify this prior to Wednesday 16 April and at 16:00, failing which the matter may be removed or struck.
8. Practice notes and heads of argument will not be accepted outside of the provisions of the practice manual read together with the Consolidated Practice Directive 1 of 2024 as amended, failing which the matter may be removed or struck from the roll.
