DIRECTIVE FOR OPPOSED MOTION COURT PROCEEDINGS BEFORE THE HONOURABLE JUSTICE KEKANA AJ FOR 17-20 FEBRUARY 2025

- 1. All matters allocated to Justice Kekana AJ will be heard in open court.
- 2. Matters have been separated and allocated for different dates. (see accompanying court roll).
- 3. The CaseLines profile and sections must be sensible and chronologically numbered, so that the relevant sections are on top.
- 4. Removals and settlements will be called first.
- 5. <u>Matters that have become settled</u>: A separate profile called SETTLEMENT BUNDLE must be created containing the following:
 - * Offer and acceptance
 - * Confirmation letter in respect of draft order
 - * Draft order

- 6. In the event of a removal:
 - CREATE A REMOVAL FOLDER AT THE TOP OF THE CASELINES PROFILE,
 - Counsel must give a full explanation for the removal (other matters could have been finalized in its place). Prepare on costs.
 - A draft order must be uploaded and a hard copy of the draft order for removal must be available at the hearing of the matter.
- 7. In the event of a removal or postponement, the judge's registrar must be informed timeously, to inform the judge not to read the papers.
- 8. Heads of argument must be uploaded on CaseLines by Friday, **07 FEBRUARY 2025**, at 16h00.
