with the relevant directives pertaining to opposed motions will apply.

- 4.2 Parties should ensure that proposed draft orders are uploaded in word format onto Caselines at least a day before a particular matter will be heard. Draft orders should indicate the hearing date of the matter, the Judge's name, and the manner in which the matter will be heard. (i.e. open court), and at the end of the draft order the names and details of all counsel/practitioners and their instructing attorneys must be included.
- 4.3 In the event that matters are to be removed, postponed or become settled, the parties must communicate same via email with the necessary notices/draft orders without delay to RSelepe@judiciary.org.za.
- 5. Introductions to the Honourable Judge shall take place in court.
