## DIRECTIVE FOR UNOPPOSED MOTION COURT PROCEEDINGS BEFORE THE HONOURABLE JUSTICE BAQWA FOR 26, 28 AND 30 MAY 2025

- 1. All matters will be heard in **COURT 2E** at 10:00.
- 2. The CaseLines profile and sections must be sensible and chronologically numbered, so that the relevant sections are on top.
- 4. Removals and settlements will be called first. Thereafter other matters will be heard according to the seniority of counsel.
- 5. <u>Matters that have become settled</u>: A separate profile called SETTLEMENT BUNDLE must be created.
- 6. In the event of a removal:
  - CREATE A REMOVAL FOLDER AT THE TOP OF THE CASELINES PROFILE,

- Counsel must give a full explanation for the removal (other matters could have been finalised in its place). Prepare on costs.
- A draft order must be uploaded and a hard copy of the draft order for removal must be available at the hearing of the matter.
- 7. In the event of a removal or postponement, the judge's registrar must be informed timeously, in order to inform the judge not to read the papers.
