1. The proceedings for Tuesday 24 and Thursday 26 June 2025 will be in open court. Please consult the day roll for the court room number to be used. Court will commence at 10H00 and introductions may be done at 09H45 (room 3.6).
2. A Practice Note comprehensively indicating the issues to be decided upon in the matter and / or bringing any recent / further developments in the matter to the attention of the Court, must be uploaded and viewable on Caseline by no later than 12h00 on Monday 23 June 2025, for matters to be heard on Tuesday 24 June 2025 and no later than 12h00 on Wednesday 25 June 2025 for matters to be heard on Thursday 26 June 2025. Failure to file a comprehensive Practice Note may result in the matter being struck off the roll.
3. The Practise Note must contain detailed contacts particulars (Cell numbers and email addresses of the person appearing). In the event that someone other than the individual indicated on the original practice note is instructed to appear, then an additional updated Practice Note must again be filed to reflect the change in identity of legal representation.
4. A proposed Draft Order, in word format, must be uploaded under a separate section on Caseline with the heading Draft Order and the date of hearing. Any and all attachments to the proposed Draft Order must be filed thereunder as well. The proposed Draft Order must contain the Judge's Name, correct date, correct case number and correctly spelled parties. **A printed copy of the proposed Draft Order and any attachments thereto must be handed up in court.**



5. No further documents are to be uploaded after the cut-off time indicated in the practice manual as read with the practice directive of this court unless with the express permission of the Honourable Judge presiding. Non-Compliance will result in the matter being removed from the roll due to papers not being in order.
6. In the event that a matter does not appear on the roll, the instructing Attorney is to prepare an affidavit on all the steps taken, as per the directive, to have had the matter enrolled. The senior Judge on unopposed motion for the enrolment date must then be approached.
7. In matters that is under the heading on the roll of *"BY THE TIME THIS ROLL WAS FINALISED THE UNDERMENTIONED COURT ONLINE MATTERS WERE NOT DISPLAYING DOCUMENTS ON CASELINE"* such will be removed if no steps are taken by the litigants to rectify access to the documents before the timeframes set out in paragraph 3 above as well as and notifying the writer hereof per email.
