- 1. Kindly note that the matters will be heard in an open court TBC before Acting Judge Matime on the 06 & 08 2025 and ALL Counsel are to appear unless their matters have been disposed of and/or dealt with timeously in terms subparagraph 2.4 hereof.
- 2. In the interim and to assist the above-mentioned Judge, please note the following:
 - 2.1. All the papers pertaining to the matters that are to be heard on the unopposed motion court must be uploaded in one file.
 - 2.2. To assist the Judge in the deliberation of the matters on her roll and to prevent matters from being struck, parties should ensure compliance with the relevant practice directives pertaining to unopposed motions.

- 2.3. Save for matters disposed of in terms of subparagraph 2.4 hereof, parties should <u>upload proposed draft orders in pdf on Caselines</u> and <u>Parties should also have a hard copy of draft order in court</u>. Draft orders should indicate when the matter will be heard, the Judge's name (i.e., Acting Judge Matime) and the manner in which the matter will be heard (i.e., open court), and at the end of the draft order the party must indicate the name and details of both counsel / practitioner and that of their instructing attorneys.
- 2.4. Notices of removals, postponements, settlements which occur before 05 May 2025 must be emailed to Amokgahla@judiciary.org.za.
