- Parties should ensure that the pleadings, Updated Practice Note, Notice of Set down and Draft Court Order are uploaded onto Caselines. The Draft Court Order should set out the date of hearing, Judge's name (i.e Acting Judge Matsemela) and the manner in which the matter will be heard (i.e open court), and name and details of Counsel/Practitioner and those of the instructing attorney should appear at the end of the draft. All documents must be uploaded two days before date of hearing.
- Attorneys for the Applicant should also ensure that a compliance declaration is uploaded onto Caselines, failing which the matter will be removed from the roll.

- 4. Matters will be dealt with by seniority, Counsel/Practitioners are to call and dispose of all their matters once on their feet.
- 5. Notices of removals should be uploaded onto Caselines and must also be **communicated timeously** to myself (Please personally email me your notice of removal). Kindly email all correspondence to Tpeele@judiciary.org.za.
- 6. Should you wish to stand down your matter, please communicate same to myself or the secretary assisting the Honorable Judge timeously to avoid the matter being struck off the roll due to non-appearance.
- 7. The decorum of the court is to be maintained at all times.
