1. All applications which had already been enrolled by 12:00 on Thursday 06 March 2025 are indicated on the roll for Urgent Applications.
2. Practitioners must ensure that all documents are uploaded on Case lines. Papers which have not been properly indexed and paginated run the risk of being struck off the roll.
3. In all matters, a Practice Note as well as Heads of Argument must be served and filed by all parties concerned. The practice note must contain full particulars of the practitioner who issues it, i.e. full names, contact number, email address and name of law firm/Bar. Full particulars of all parties on whom the practice note is served must also appear in the practice note.
4. The Practice Note and Heads of Argument must be uploaded on case lines by no later than 13h00 the day before the hearing, or where answering affidavit papers are delivered by no later than 16h00.
5. Parties must upload their draft orders on case lines and email them in word format to amokgahla@judiciary.org.za.

6. Filing of papers which practitioners were unable to upload on Case lines, must be done via email provided above, with an explanation why it was not possible to upload on Case lines. The Judge's clerk must be informed telephonically that an email has been sent.
7. **Matters will be heard in Court (TBC).**
8. Parties may elect either to address the court on virtual platform or may elect that their matters be disposed of on papers only without appearance.
9. Parties who elect their matters to be heard on papers only, must inform the Judge's clerk by 9h00 before the hearing of the matter.
10. Settlements and removals to be done in court on Monday 11 March 2025.
