**NOTICE:**

“16.8. In those cases which are conducted by video-link and where a party appears in person:

16.8.1. That litigant shall approach the designated official at the court building who shall render assistance to that litigant through the use of the virtual courtroom. A notice to this effect that shall be posted in the foyer of the court by the Judge’s secretary or,

16.8.2. Where such a litigant’s contact details are known, the secretary of the Judge shall endeavour to make contact to communicate the relevant information.

16.8.3. Where such litigant has personal access to teleconferencing facilities a link may be set up accordingly.”

Where litigants in person have failed to file practice notes in their matters, they are to contact the registrar of the Presiding Judge and provide their contact details, including their cellular telephone number and email address. The registrar’s contact details are set out below.

Please note that the allocated time for hearing, as indicated on the roll, may change in the event that a preceding matter runs over the time allotted or is completed earlier.
