2. Counsels and Litigants introductions will be conducted in court.
3. Counsels must hold themselves available to be heard earlier on the day for which their matter is allocated. Counsel are not expected to hold themselves available for any day other than the day for which their matter is allocated.
4. All matters must be accessible on Caselines and the Judge's secretary must be invited to the Caselines file as well. Further, matters must be properly bundled/activated on Caselines on or before 14h00 noon on **MONDAY, 07 July 2025**. Failure to comply will lead to the matter being struck off from the Court's roll.
5. Draft orders must be uploaded onto Caselines and 1 copy handed up in Court. Counsel must ensure that the draft orders have the correct case number and the correct prayers prayed for are included, as no order will be amended after it has been granted in court.
6. Any removals, settlements and postponements should kindly be communicated to the Judges Secretary as soon as possible.

7. Counsel /Practitioners should ensure compliance with the relevant Directives pertaining to unopposed motions.
