BEFORE ACTING JUSTICE DE BEER

4. Save with the leave of the court, no documents (save for practice notes and

heads of argument) may be uploaded after 16h00 on Thursday, 10 July

2025.

5. In all opposed applications, heads of argument must be uploaded by 10h00

on Monday, 14 July 2025.

6. Applications will be heard in open court on the date and time allocated.

Practitioners may be requested to avail themselves earlier. After-hours

applications will be heard via MS Teams at the indicated time, and a link will

be sent.

8. Parties are requested to prepare draft orders to be handed up in court.
