**URGENT COURT DIRECTIVE: 14 JULY 2025 TO 18 JULY 2025**

**BEFORE ACTING JUSTICE FERREIRA**

1. Strict compliance with the Practice Directive regarding urgent court applications must be observed (paragraph 28, read with the Practice Manual, where applicable)
2. A practice note must be filed in all matters, **by 17h00 on 11 July 2025**, setting out the following:
  - 2.1 The grounds of urgency;
  - 2.2 Nature of the relief sought;
  - 2.3 Which portion of the papers should be read;
  - 2.4 The estimated duration of the hearing; and
  - 2.5 Contact details of the legal practitioners.
3. An allocated roll will be published during Monday, 14 July 2025. An allocation does not necessarily indicate that the application is deemed urgent.

4. Save with the leave of the court, no documents (save for practice notes and heads of argument) may be uploaded after 16h00 on Thursday, 10 July 2025.
5. In all opposed applications, heads of argument must be uploaded by 10h00 on Monday, 14 July 2025.
6. Applications will be heard in open court on the date and time allocated. Practitioners may be requested to avail themselves earlier. After-hours applications will be heard via MS Teams at the indicated time, and a link will be sent.

8. Parties are requested to prepare draft orders to be handed up in court.
