Directives:

1. Acting Judge Groenewald will be in the opposed motion court during the week of **28 July 2025 to 1 August 2025**. Legal representatives are requested to verify the court venue on the day roll. The allocated roll for matters before Acting Judge Groenewald is attached hereto.

2. Any removals, postponements and settlements can be called by counsel in open court on **Monday, 28 July 2025** at **10:00**. The judge's secretary should immediately be informed if a matter is to be removed, postponed, or has become settled or if for any other reason the papers need not be read.
3. All Legal Practitioners must deliver **hard copies** of the relevant documents to the reception at **Brooklyn Advocates Chambers, 220 Dey Street, Pretoria** by no later than **15:00** on **Thursday, 24 July 2025**. The hard copies should be printed from CaseLines and must contain the Caselines pagination.
4. All matters will be heard in **open court**. Court will start at **10:00** unless otherwise indicated on the allocated roll. Introductions will be conducted at **9:45** or 15 minutes prior to appearance.
5. Attention is drawn to the provisions of the **Consolidated Practice Directive [25.17 to 25.19]** dealing with **joint practice notes**. To the extent that a joint practice note has not been uploaded, the parties must do so before **14:00** on **24 July 2025**.
6. Should a matter for any reason not proceed on the given date, you are directed to expeditiously inform the office of Acting Judge Groenewald via email to **Ms Nyameka Mhlaba (Judge's Secretary) : NyMhlaba@judiciary.org.za** and to upload the notice of removal to Caselines. A party shall not unilaterally remove a matter from the roll.
7. Save where matters are indicated to be allocated for purposes of a roll call, all parties must attend to court on the dates and

times indicated below. Parties should be mindful that the allocated date or time may change. Counsel should structure their arguments considering the estimated duration allocated to the matter.

8. Parties should ensure that the proposed draft orders are uploaded onto Caselines **and** emailed in Word format to **Ms Nyameka Mhlaba (Judge's Secretary) : NyMhlaba@judiciary.org.za** at least **three days** before a particular matter will be heard. Parties must bring **two hard copies** of the draft order to Court. Once an order is made, the parties will receive a copy of the order via CaseLines.
9. Draft orders should indicate the hearing date of the matter, the Judge's name, the manner in which the matter will be heard (i.e. open court), and at the end of the draft order, the names and details of all counsel/practitioners and of their instructing attorneys must be included.
10. Queries regarding any opposed motion set down for hearing must be addressed to the secretary of the presiding judge to whom the matter has been allocated for hearing. No direct communications should be directed to the judge.
11. Kindly mention the roll number and the case number in the subject line of your emails.
