**Directives:**

- (1) To the extent that the parties have not uploaded a joint practice note (*or a unilateral practice note – if applicable*), they are directed to do so by no later than Friday, 25 July 2025 at 14:00. The practice note must *inter alia* indicate the nature of the application, and an updated estimate duration.**
- (2) Introduction will be in chambers 20 minutes before the scheduled time (4<sup>th</sup> Floor, Room 4.1).**
- (3) The date and time of the hearing of each matter are set out in the allocated roll below.**
- (4) Matters will be in open court. Parties need to appear on the date and the time reflected on the allocated roll below.**
- (5) Parties must check the allocated court room on the day roll.**

- (6) Proposed draft orders are to be uploaded in word format onto Caselines at least a day before a particular matter will be heard. Draft orders must contain the Judge's name, date, mode of hearing, the number on the roll and correct case number.
- (7) Parties must bring ONE hard copy of the Draft Order sought to open court.
