4. If the parties need a signed copy by the Judge in court on the day, more copies should be handed up in court.
5. Do not e-mail any documents or draft orders.
6. The documents should be in order and on Court online or caselines.

7. No matter will stand down to later in the week.
8. The order made in court will be signed and stamped by the Registrar and uploaded within 7 court days.
9. Legal Practitioners do not have to introduce themselves to the Judge in chambers, they may introduce themselves in court when their matter is called.
