1. Kindly note that the matters will be heard in an open court **(TBC)** before Griessel AJ on the 18-22 MAY 2026, and Counsel are to appear unless their matters have been disposed of and/or dealt with timeously in terms of subparagraph 2.4 hereof.

2. In the interim and to assist the above-mentioned Judge, please note the following:
 - 2.1. All the papers pertaining to the matters that are to be heard on the opposed motion court are to be uploaded in one file.
 - 2.2. To assist the Judge in the deliberation of the matters on his roll and to prevent matters from being struck, parties should ensure compliance with the relevant practice directives pertaining to opposed motions.

- 2.3. Save for matters disposed of in terms of subparagraph 2.5 hereof, parties should **upload proposed draft orders in pdf on Caselines**. Parties should also email proposed **draft orders in Word format** to: Amokgahla@judiciary.org.za. Draft orders should indicate when the matter will be heard, the Judge's name (i.e., Griessel AJ) and the manner in which the matter will be heard (i.e., open court), and at the end of the draft order, the party must indicate the name and details of both counsel / practitioner and that of their instructing attorneys.
- 2.4. Notices of removals, postponements, settlements which occur before 18 May 2026 must be emailed to the email address provided in subparagraph 2.3 hereof on 15 May 2026 at 12H00 midday.
