**URGENT COURT**  
**BEFORE THE HONOURABLE MADAM JUSTICE KHUMALO (Ms)**  
**2024 : TERM 2 : WEEK 6 (17 to 24 May 2024)**

1. Matters enrolled will be heard using the MS Teams virtual platform.
2. In matters where filing was not done and not ready as per the practise directive at 12:00 on Thursday 16 May 2024 (i.e. all relevant affidavits filed and the case indexed and paginated) and where no link received, such matters will be struck from the roll, they will not be heard, unless there is good cause or exceptional circumstances.
3. Litigant are to ensure that in matters that was issued and created using the Court-on-Line platform, **all the documents is accessible and viewable on Caseline**. If any problems are experienced, the OCJ Helpdesk is to be approached for assistance and the Judge's Chambers may be contacted TIMEOUSLY.
4. A practice note must be filed setting out the following:
  - 4.1 . The grounds for urgency;
  - 4.2 Nature of relief sought;
  - 4.3 Total number of pages;
  - 4.4 An indication which portion of the papers must be read and which not;



- 4.5 The estimated duration of the matter;
  - 4.6 If there is non-compliance with the updated AJP's directives issued recently or the practice directives for urgent court, the reasons for such deviation;
  - 4.7 Contact details for the legal practitioners, which must include both cell phone numbers and email addresses.
5. Where **no certificate of urgency** has been filed and/or **no practice note** has been filed the matter will be struck from the roll unless good cause is shown for non-compliance as per the issued directive.
  6. **Please also note that the master bundle must be properly indexed and paginated and uploaded. Each document must be individually identified in the master bundle, including annexures.** If not, it will result in your matter being struck from the roll. This must be attended to before 16h00 Friday 17 May 2024.
  7. The profiles on Caselines will be frozen at 16h00 on Friday, 15 July 2022. No piece-meal filing of affidavits will be allowed.
  8. In all opposed matters, heads of argument should have been filed by both parties before 16h00 on Friday 15 July 2022. Strict regard will be had to the rules of urgency. As the profiles will be frozen, please email the heads of argument to [EVanDerMerwe@judiciary.org.za](mailto:EVanDerMerwe@judiciary.org.za).
  9. If there is non-compliance with the practice directive, the matter will be struck from the roll, unless good cause is shown for non-compliance.
  10. There will be no roll-call on Tuesday 21 May 2024. The virtual proceeding will start on Tuesday 21 May 2024 at 10h00 in accordance with allocation roll below and that will be circulated with this directive unless specifically otherwise stated. Legal practitioners are all urged to log on to the MS Teams virtual hearings at 10H00.
  11. Daily links will be, as default, posted on the Pretoria Attorneys Associations WhatsApp groups.
  12. An allocation does NOT mean that the matter is considered sufficiently urgent to be heard on the merits. Submissions will need to be made regarding the grounds of urgency.



13. It is the parties' responsibility to obtain dates from the registrar for return dates.
14. All new applications, after hours or during court hours, must be forwarded to Judge Khumalo's Registrar (Mr E van der Merwe). The litigant MUST include telephonic contact detail. In this regard the provisions of sub-paragraphs 7.1 to 7.4 of chapter 13.24 of the Practice Manual will apply *mutatis mutandis*.
15. Matters that are to be removed must be communicated by e-mail to [evandermerwe@judiciary.org.za](mailto:evandermerwe@judiciary.org.za) as soon as a party becomes aware that it will not proceed.
