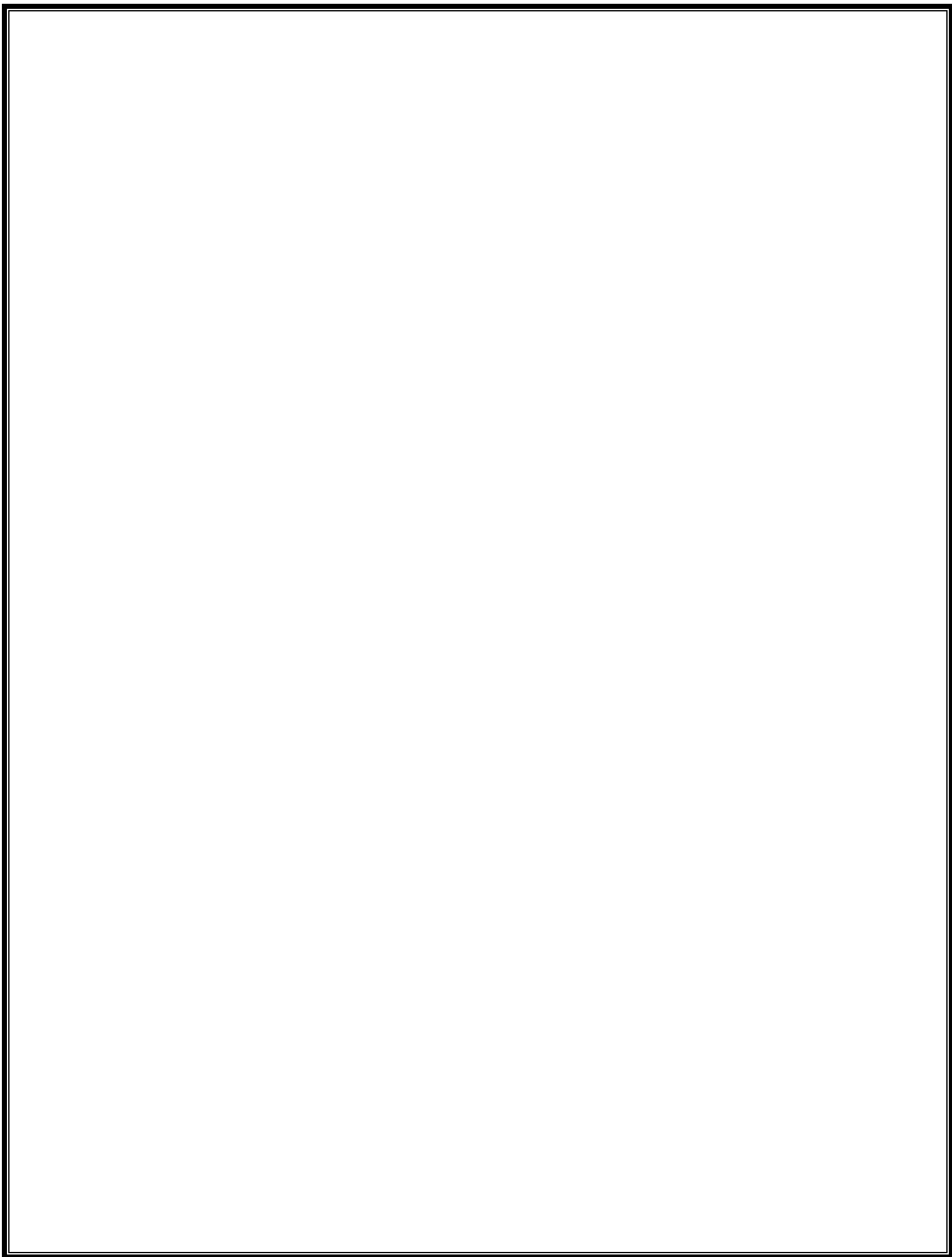
DIRECTIVE: DEFAULT JUDGMENT COURT – 26 MAY 2026 AND 28 MAY 2026
