- 1. **Introductions** at 9h45, office number 1.9. Parties are required to attend court only on the designated date for their specific matter. No roll call will be conducted for these matters.
- 2. In accordance with paras 172 to 183 of the directive of 11 June 2021, in all matters set down for Tuesday 18 November 2025, complete papers must have been filed on CaseLines by the preceding Thursday at 12h00. It is the applicant's obligation to ensure that the papers are available for reading on CaseLines.
- 3. If the papers are not complete by 12h00 on the preceding Thursday, an explanation must be given on affidavit. Failure to comply with the directive may lead to the matter being struck from the roll. Papers that are filed **after** 12h00 on Thursday 13 November 2025 will not be read unless a satisfactory explanation is given on affidavit at the time when the papers are filed.
- 4. A practice note must be filed by all parties appearing in a matter, dealing specifically with urgency, and giving a brief synopsis of the matter, and a summary of the issues to be determined. The practice note should be filed on CaseLines by no later than 12h00 on Thursday 13 November 2025. If any part of the record is not required to be read, the practice note shall so state.
- 5. All cases set down for hearing **other** than for 10h00 on 18 November 2025 shall be considered by Judge Swanepoel in order to determine whether such matters are sufficiently urgent to be enrolled. In order for the Judge to make a proper determination on urgency, the practice note and the founding affidavit must deal fully with the reasons why the matter should be heard urgently on that particular day.
