URGENT COURT ROLL AND A DIRECTIVE FOR A WEEK COMMENCING ON THE 18TH NOVEMBER 2025

DIRECTIVE:

- 1. Matters will be heard in Open Court.
- 2. If there is non-compliance with this practice directive, the matter will be struck from the roll, unless good cause is shown for non-compliance.
- 3. All Counsel need to appear on Tuesday 18 November 2025 for roll call at 10h00.
- 4. In accordance with paras 172 to 183 of the directive of 11 June 2021, in all matters set down for Tuesday 18 November 2025, complete papers must have been filed on CaseLine by the preceding Thursday at 12h00. It is the applicant's obligation to ensure that the papers are available for reading on CaseLine.

- 5. If the papers are not complete by 12h00 on the preceding Thursday, an explanation must be given on affidavit. Failure to comply with the directive may lead to the matter being struck from the roll. Papers that are filed after 12h00 on Thursday 13 November 2025 will not be read unless a satisfactory explanation is given on affidavit at the time when the papers are filed.
- 6. A practice note setting out the following:
 - 6.1 particulars and contact details of the legal practitioners;
 - 6.2 nature of the relief sought (without referring to the notice of motion);
 - 6.3 total number of pages;
 - 6.4 a brief summary of the factual and legal issues involved;
 - 6.5 a clear indication (without repeating the heads of argument) which portion of the papers must be read and which not;
 - 6.6 the main issues to be considered;
 - 6.7 a brief summary of the urgency, or absence thereof;
 - 6.8 whether there has been service by the sheriff and if not, why not;
 - 6.9 estimated duration;
 - 6.10 whether the matter is opposed;
 - 6.11 service of process in all urgent applications shall comply with the Rules of Court. Where an agreement was reached by all the representatives if all parties to vary the requirements of the Rules to facilitate a wholly electronic exchange of papers, this must be specifically stated.

The practice note should be filed on CaseLine by no later than 16h00 on Friday 14 November 2025.

7. In all matters which are opposed, the parties' respective heads of argument

[HOA] and practice notes must be uploaded onto Caselines according to the following timelines: the Applicant: before 12h00 on Saturday, 15 November 2025 and Respondent: before 12h00 on Sunday 16 November 2025, save where leave for an extension has been granted by the Judge no further or other documents maybe uploaded onto caselines.

- 8. In matters that are settled or unopposed draft orders in the format referred to in paragraph 14, are to be emailed to the Judges' secretary by no later than 13h00 on Monday, 17 November 2025 and counsel is to appear to make the draft an order of court.
- Where matters are removed, a notice of removal must be uploaded onto
 Caselines and sent via email to the presiding Judges' secretary as soon as possible.
- 10. All cases set down for hearing other than for 10h00 on 18 November 2025 shall be considered by Judge van der Merwe AJ to determine whether such matters are sufficiently urgent to be enrolled. For the Judge to make a proper determination on urgency, the practice note and the founding affidavit must deal fully with the reasons why the matter should be heard urgently on that particular day.
