**OPPOSED MOTION: WEEK OF 24 NOVEMBER – 28 NOVEMBER 2025  
BEFORE THE HONOURABLE MR ACTING JUSTICE TISANI**

**DIRECTIVES:**

1. The Court will sit at 10h00.
2. Allocations are set out in terms of the table below, and parties need only attend court on the date(s) and time indicated, subject to what is set out below:
  - 2.1. In any matter that is to be removed, the parties must immediately inform the Judge's Secretary, and upload a Notice of Removal on Caselines.
  - 2.2. In any matter that is to be postponed and/or settled by agreement prior to the allocated date, the parties must immediately inform the Judge's Secretary, and may attend court at 10h00 on any of the allocated dates for that purpose.
3. Matters will be conducted in Open Court. Introductions will also be done in Open Court.
4. Draft orders: parties must have a hard copy to-hand up in Court, with a copy uploaded to Caselines.
5. The draft order must comply with the practice directive, i.e. the Judge's name, date, court room, etc. Including the below disclaimer:
