A hard copy of the heads of argument and draft order to be made available for the court before the matter commences.
- 3. Parties should ensure compliance with the relevant directives pertaining to delivery and uploading of both parties' heads of argument or court orders obtained through an application to compel.
- 4. Kindly take further note that the uploading of documents on CaseLines outside the stipulates times and without condonation will result in the matter being struck

off the roll and cost de bonis propriis may be ordered against the errant

practitioner.

5. Parties should upload proposed draft orders onto CaseLines in word format. Draft

orders should obtain a disclaimer, indicating date of hearing, judge's name (i.e.

Klopper AJ), manner of hearing (open court) and the name and details of

counsel/practitioner and those of instructing attorney.

6. Counsel/practitioners appearing in an open court should be robed.

Counsel/practitioners not addressing the court should always maintain the

quorum of the court at all times.

7. Notices of removals, postponements, settlements should be uploaded on

CaseLines or sent to LNyilika@judiciary.org.za by no later than 31 October 2025.
