**URGENT COURT DIRECTIVE & ROLL FOR THE WEEK COMMENCING ON 31
OCTOBER TO 7 NOVEMBER 2025**

DIRECTIVES

1. All applications that have already been enrolled by 12:00 on 30 October 2025 (when the roll closed) are listed on the Roll for Urgent Applications. Where a matter is allocated to Roux AJ, the allocation does NOT mean that the matter is necessarily urgent enough to be heard on its merits.
2. In all matters, whether opposed or unopposed, a **Practice Note, Heads of Argument, and Relevant Authority List** must also be served and filed (on Caselines only and not to be sent to the Judge's secretary) by all parties concerned: -

by no later than Friday, 31 October 2025, at 16:00.

Supplementary practice notes (**where STRICKLY necessary**) may be filed by **Monday, 3 November 2025, at 09h00**

3. There will be roll call in open court on Monday, **3 November 2025 at 10h00 4C.**
4. **Failure to file Practice Note(s) and/or Heads of Argument promptly will indicate that the party concerned has no appearance and may lead to the application being struck off the roll or dealt with in their absence.**
5. The **practice note** must indicate the following:
 - 5.1 Particulars and **contact details** of all the legal practitioners;
 - 5.2 Whether the matter is **opposed or not**

- 5.3 **Nature of the relief sought** (without referring to the notice of motion);
 - 5.4 **A brief summary of the factual as well as legal issues involved;**
 - 5.5 A clear indication (without referring to the heads of argument) which portion of the **papers must be read** and which not;
 - 5.6 **The main issues to be considered;**
 - 5.7 Whether there was **service by the sheriff**, and if not, why not? (unopposed applications);
 - 5.8 Estimated **duration**;
6. Rules pertaining to urgency **will be strictly enforced**.
7. **Service of process must comply with the prescripts of the Uniform Rules of Court, absent which an affidavit shall comprehensively deal with the adequacy of service** Deviations will only be condoned if good cause is shown. Where the respective parties' legal representatives reached an agreement to provide for the electronic exchange of papers, this must be specifically stated in the practice note.
8. **All new applications during court hours must first be registered with the Registrar of the Urgent Court and then brought to the attention of Acting Justice Roux's secretary, IF SO ALLOCATED**
9. **Where matters are opposed**, parties must either upload a bundle of authorities consisting of the referred cases' head notes and relevant passages or hand up a hardcopy bundle when the matter is called.
10. The urgent Court cellular number for Pretoria is: 068 104 7107. The number **is only to be used** outside of ordinary court hours. The number is **not** to be used for general enquiries. The phone will only be answered after normal court hours.
